Original Summary of Services

Amendment (#11)

For services provided from Qwest Corporation to Qwest LD Corp., a Section 272 affiliate.

Description of Services Provided:

Finance Hourly Rate Services – providing general accounting and business advice for Qwest LD Corp. (QLDC) business transactions. This also includes functional support for finance systems, generating reports, data analysis and cash management processes. Services include pulling data from Peoplesoft Asset Manager to create an access database. Includes development of a methodology for creating detailed asset records. As well as the following services:

- Federal & State Regulatory Reporting – analysis & preparation of Federal and State regulatory reports.
- Universal Service Fund Support – providing disbursements to customers of the Universal Service Fund (USF), supervision of disbursements and USF consultation, methods and assistance to QLDC as well as interfacing with the Information Technologies personnel to develop requirements for the USF database programs.
- Tax Accounting – providing tax support for income tax accounting calculations, consolidations and tax issues.
- Asset Accounting and Operations – providing the recording of capital assets, providing the physical inventory, calculating depreciation and meeting all fixed asset tax requirements.
- Capital Recovery- providing depreciation parameters, depreciation budgets and advice regarding depreciation issues.
- Finance Billing Support-provide Finance support functions for QLDC related to affiliate transactions. This could involve activities such as the calculation of the pricing of services that QLDC will bill, tracking and calculating monthly QLDC billing amounts, generating invoices on behalf of QLDC or other support needed by QLDC.
- Revenue Operations – providing support to the migration of QLDC billing systems into the Revenue Journal System. Work includes providing methods and procedures, review of user requirements, functional design meetings, creation of test requirements, validate test output. Ongoing work activities would include initiate and validate table changes and the monitoring of daily production files.

Finance Systems - Accounts Payable Support – providing the processing of employee and vendor invoices and payments and accounts payable reconciliation.

Finance Systems - General Ledger Processing – providing support personnel for the processing and maintenance of the general ledger system.
